

REGULATIONS

1. As part of the "Luso Half Marathon" program, the Mimosa Passeio da Família is a social non competitive, walking race, open to all who want to participate. It will take place on Saturday morning, October 7th, at 11:00 am.

2. The concentration for this event will be at Rossio dos Olivais. This race is intended to be a healthy 4km walk, at low speed, for the whole family.

3. All participants will receive t-shirts, medals and various gifts.

4. Entries must be made on the event's website, at https://www.maratonaclubedeportugal.com/.

5. Participants, duly registered, will be able to collect their bib number and respective "race kit", at the Sala Tejo – Altice Arena, on October 5^{th} and 6^{th} , between 10:00 am and 8:00 pm, with no type of documentation being distributed on the day of the Walk.

a) To collect the "race kit", it will be necessary to present the respective proof sent by the organization to the participant's email and the respective identification document.

6. The bib number is non-transferable and when used by another participant it will result in his/her disqualification.

7. The organization has structured a medical assistance service, under the guidance of a specialized team of professionals, although it is not responsible for any accident that may occur during this event.

8. Athletes will benefit from personal accident insurance, as provided for in paragraph 15 of article 18 of Decree-Law no. treatment expenses up to \notin 4,000.00.



9. The parent/guardian of the participant, when registering, authorizes the transfer, free of charge and unconditionally, to the organization of the event and to its associates and sponsors, the rights to use the image of their student, as captured in the filming or photos that will take place during the event, authorizing their reproduction in communicational support pieces.

10. The organization reserves the right to use the database with the elements filled in by the guardians of the participants in their eventual promotional or other actions.

11. When registering, the participants' parents/guardians automatically declare that they are in agreement with the following disclaimer:

a) I have read and agree with the Regulations of Marathon Clube de Portugal, available on the Passeio website;

b) I am aware of the state of health of my student and I am responsible for being, physically and psychologically, able to participate in the tour;

c) I assume that I will abstain my student from participating in the Tour if their health conditions change after registration;

d) I am aware of the content of the insurance policy in force and have read its specifications, contained in the Tour Regulations;

e) By participating in the event, I authorize, free of charge and unconditionally, that the organization and the partners of the test use the image of my student. By this instrument, I grant all rights to use the image, of my student, captured in photographs and footage that will take place during the event, waiving the receipt of any amount that may be earned with its dissemination in communicational pieces of support;

f) I declare that my student participates in the Tour of their own free will, exempting the organization, partners, directors, employees and other companies linked to the organization of the event from any liability resulting from their participation in the Tour, before, during and after the same (eg loss of personal effects due to theft or other circumstances).



12. The tour's route may be altered or canceled due to factors external to the organization (extreme weather conditions, demonstrations, strikes, government restrictions, works, security, etc.). The organization may, in exceptional cases, change the race times.
