

REGULATION

1. As part of the “Luso Half Marathon” program, the EDP Mini Champions social event takes place on the afternoon of Saturday, October 8th, at 4:00 pm.
2. The entire route will take place at Parque Expo (Rossio dos Olivais / Cais Portugêses). With Start and Finish installed next to the Portugal Pavilion, the course will be about 600m / 900m / 1500 m.
3. Entries must be made on the race's website, at <http://www.maratonaclubedeportugal.com/>
4. Duly registered athletes will be able to collect their bib number and respective “Athletes kit” at the Pavilhão Carlos Lopes, on October 6th and 7th, from 10:00 am to 8:00 pm, with no type of documentation being distributed on the day of the event.
 - a) To collect the “Athletes kit”, it will be necessary to present the respective proof sent by the organization to the athlete's email and the respective identification document.
5. The bib number is non-transferable and when used by another athlete, it will result in his/her disqualification.
6. In terms of final results, the age groups are considered based on the following ages: 6/8 years old, 9/11 years old, 12/13 years old and 14/16 years old. The age considered is the age of the participant on the day of the race.
7. The organization has structured a medical assistance service, under the guidance of a specialized team of professionals, although it is not responsible for any accident that may occur during this event.
8. Athletes will benefit from personal accident insurance, as provided for in paragraph 15 of article 18 of Decree-Law no. treatment expenses up to €4,000.00.
9. The parent/ guardian of the participant, when registering, authorizes the transfer, free of charge and unconditionally, to the organization of the event and to its associates and sponsors, the rights to use the image of their student, as captured in the filming or photos that will take place during the event, authorizing their reproduction in communicational support pieces.
10. The organization reserves the right to use the database with the elements filled in by the guardians of the participants in their eventual promotional or other actions.

11. When registering, the participants' parents/guardians automatically declare that they are in agreement with the following disclaimer:

a) I have read and I agree with the Regulations of the Maratona Clube de Portugal, available on the event's website;

b) I am aware of the state of health of my student and I am responsible for being, physically and psychologically, able to participate in the race;

c) I assume that I will abstain my student from participating in the race if their health conditions change after registration;

d) I am aware of the content of the insurance policy in force and have read its specifications, contained in the Regulation of the event;

e) By participating in the race, I authorize, free of charge and unconditionally, that the organization and the partners of the test use the image of my student. By this instrument, I grant all rights to use the image, of my student, captured in photographs and footage that will take place during the race, waiving the receipt of any amount that may be earned with its dissemination in communicational pieces of support;

f) I declare that my student participates in the race of their own free will, exempting the organization, partners, directors, employees and other companies linked to the organization of the event from any liability resulting from their participation in the race, before, during and after it (eg loss of personal objects due to theft or other circumstances).

12. The race course may be altered or canceled due to factors external to the organization (extreme weather conditions, demonstrations, strikes, government restrictions, works, security, etc.). The organization may, in exceptional cases, change the race times.
