



## REGULATIONS

### EDP 8K

#### Article 1

##### General Information

1. These Regulations govern the organization of the "EDP 8K", in the city of Lisbon, as part of the "EDP Lisbon Marathon" ("EDP 8K" or "Race").
2. The compliance with the provisions of these Regulations does not exempt the subsidiary application of the applicable legislation and regulations.
3. The EDP 8K is an organization of the MARATONA CLUB OF PORTUGAL (henceforth MCP), with headquarters at Av. João de Freitas Branco, 10 Laveiras, 2760-073 Oeiras, Portugal
4. The EDP 8K will take place on October 8th, 2023, with a scheduled start time at 10:30am. The event will be broadcast live on RTP 1 and has the support of the Lisbon Municipality, as well as other official entities, including the PNDpT - Programa Nacional Desporto para Todos (National Sport Program for All).

#### Article 2

##### Route and duration

1. The EDP 8K will have a course of 8,000 meters.
2. The EDP 8K will have a time limit of 2h30m (two hours and thirty minutes) from the start, finishing at 1:00pm (one o'clock).
3. After the time limit of the EDP 8K, the competent authorities will re-establish the road circulation, so all the athletes that may still be running the Race, must detour to the adjacent pavements or pedestrian paths or get in the bus made available by the MCP to collect the athletes participating in the Race. The MCP is not responsible for any accident that may occur after the end of the EDP 8K time limit.

#### Article 3

##### Departure, itinerary and arrival point

1. The Departure of the "EDP 8K", will take place at 10:30am, in Lisbon, on the board of "Ponte Vasco da Gama" and the arrival will be at Alameda dos Oceanos, in front of the



Altice Arena, next to the Estátua do “Homem Sol”, also in Lisbon. The itinerary will be according to the map published in the Race website, available in [www.maratonaclubedeportugal.com](http://www.maratonaclubedeportugal.com)

2. The route will be identical to the Luso Half Marathon, until Km 7

#### **Article 4**

##### **Times and Starting Boxes**

1. There will be no starting boxes in this event.

#### **Article 5**

##### **Supply Stations**

1. There will be an adequate official supply station service at Km 6 and near the finish line.

#### **Article 6**

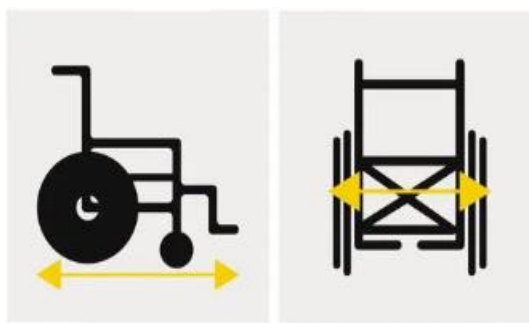
##### **Registrations**

1. The registrations in the event must be done online, at the official website of the Race at [www.maratonaclubedeportugal.com](http://www.maratonaclubedeportugal.com)
2. There will be a maximum of 8,000 (eight thousand) athletes in the EDP 8K.
3. Registration in the event is limited to participants over 9 years old, provided that they are accompanied by a responsible person (over 18 years old).
4. The registrations in the event are personal and non-transferable
5. All the requests for changes in the registration for the Event should be made up to 1 (one) month before the date of the EDP 8K, through the email [info@maratonadeportugal.com](mailto:info@maratonadeportugal.com)
6. All requests to change the registration in the race made after the limit referred in the previous number, will have an administrative cost of 15 (fifteen) Euros, not guaranteeing the personalization of the bib.
7. Without prior notice, the MCP may at any time suspend or extend the Race entry deadlines or add or limit the number of entries in the Race according to technical or structural availabilities.
8. All athletes who wish to participate in the EDP 8K must ensure that they have the necessary health conditions for the effort inherent to the Race, assuming, for the effect, the Term of Responsibility foreseen in article 23 of the present Regulation.

#### **Article 7**

##### **Registration and participation of people with visual impairment and mobility impairment**

1. To guarantee the respect for the principle of equality (non-discrimination) regarding the participation of disabled athletes, indistinctly of the category of disability and of athletes with conditioned mobility, as from the 2023 edition, it will be possible for people with conditioned mobility, who use a wheelchair, to participate in the Event, if they are assisted/pushed by a third party. Only "everyday wheelchairs" will be considered eligible for participation in the Race, no track chairs, handbikes or tricycles will be allowed.
2. Without prejudice to the provisions of Article 27 of these regulations, a maximum limit of 10 (ten) places is established for participants with limited mobility, requiring the use of a wheelchair, if they are not aided by any mechanical aid device.
3. When registering for the Event, the participant with a wheelchair must provide the MCP with the wheelchair model and respective photo, for prior approval purposes, which must occur with a minimum antecedence of 3 (three) weeks before the Event.
4. The wheelchair models to be approved may not be wider than 70cm wide by 1.10cm long, as illustrated below. All other models will be assessed by the MCP for possible approval.



5. For safety reasons, participants using wheelchairs must be accompanied by an assistance team composed by two persons (to be indicated by the participant).
6. The registration of the referred assistance team or guide must be done at the same time and associated to the registration of the participant that will use the wheelchair, in a proper form, not being subject to any fee or counterpart.
7. The participants with limited mobility, with the need to use a wheelchair, will start from the end of the peloton.
8. To receive, at the end, the official medal of the Event, the participant with disability/mobility impairment must complete the entire Event.



9. Visually impaired participants have the right to participate in the Event with a guide, upon presentation of a medical certificate of multi-use disability with 60% or more disability.
10. Participants with visual impairment and participants with limited mobility, with the need to use a wheelchair, must register exclusively through the email [inscricoes.pdvmc@maratonaportugal.com](mailto:inscricoes.pdvmc@maratonaportugal.com)
11. The MCP will not be responsible for any registration of athletes with visual impairment or mobility impairment, with the need to use a wheelchair, made by any means other than the email address provided above for the purpose, being considered invalid and reserving the right to not authorize the participation of the athletes in question.
12. Participants with visual impairment or mobility impairment requiring a wheelchair will not be charged an entry fee.
13. The participants with mobility impairments and with the need to use a wheelchair will be informed, after the registration in the Event, how to proceed to access the starting area. For safety reasons and logistic viability, the way these participants will have access to the start zone must be previously agreed and authorized by the MCP.
14. Any participant in wheelchair that appears at the start zone of the Event without having been previously authorized by the MCP, may have his participation refused.

#### **Article 8**

##### **Registration Fee**

1. Registration fees are set annually by the MCP.
2. Visual and mobility impaired athletes, as well as the accompanying persons assisting them, are exempt from the registration fee.
3. The payment of the registration fees must be made through the means indicated by the MCP.

#### **Article 9**

##### **Participation kit**

1. The "Participation Kit" in the Race will be given to you when you pick up your bib number and will contain:
  - a) A technical fibre t-shirt (5 sizes, being the stock of sizes distributed according to availability). In case of stock rupture in any size, the athlete will be offered another size;
  - b) A bib number;
  - c) An individual equipment bag;
  - d) Other gifts and information from sponsors.



## **Article 10**

### **Collecting of the Participation Kit**

1. The athletes duly registered in the Race can collect their bib and respective "Participation Kit" at Sala Tejo - Altice Arena between 05, 06 and 07 October 2023, from 10:00am to 08:00pm, and no documentation or kits will be distributed on the day of the Race. No kits will be handed out in any other moment other than the ones designated here.
2. To collect the bib it will be necessary to present the respective proof of payment of the registration fee, or the printed document of the online registration, as well as the identification document of the respective athlete.
3. In the case of athletes with disabilities/mobility impairments for which there is a need for assistance by a companion, the latter may collect the bib and the respective "Participation Kit".
4. On delivery of the "Participation Kit" no size change requests for technical fibre t-shirts will be accepted.

## **Article 11**

### **Bib number**

1. The Race bib is personal and non-transferable, and may not, under any circumstances, be reproduced, replicated, or modified. Its use by a third party will imply the disqualification of the third party and the suspension of participation in subsequent editions of the Race.
2. The MCP recommends all athletes to fill in their personal data in the back of their bib for safety reasons only, namely in case of any accident, physical indisposition, or any other emergency, during the Event.
3. The athletes without bib number will not be authorized to circulate in the course of the Race.

## **Article 12**

### ***"Special VIP" bibs***

1. There will be no "Special Vip" bibs at EDP 8K

## **Article 13**



### *"VIP Start" bibs*

1. There will be "VIP Start" bibs, in limited number.
2. The MCP reserves the right to give "VIP Start" bibs to athletes/personalities invited by them.
3. The athletes with "VIP Start" bibs will have the right to:
  - a) Access to the front of the race.

### **Article 14**

#### **Disqualification from EDP 8K**

1. Without prejudice of the fact that the Race is not a competitive event and that there are no disqualification issues, it is recommended to all the participants of the Race that they use the dorsal of another athlete
  - a) Do not use the bib of another athlete;
  - b) Do not damage the bib;
  - c) Have the bib placed in the chest area, as a bad placement of the bib implies possible failure in obtaining the results;
  - d) Not to fold the bib in order to reduce its size;
  - e) Use their bib during the whole course of the Event
  - f) Do not jump over the rail at the start or finish zone;
  - g) Respect the Race signaling, and the instructions given by the MCP
  - h) Not to falsify any element related to their registration in the Event
  - i) Guarantee their physical well-being before the start
  - j) Not use two bibs with different numbers
  - k) Don't show an anti-sportive behavior and comply with the rules stipulated in this regulation and the safety and hygiene instructions given by the MCP staff and by the competent entities, before, during and after the Event.

### **Article 15**

#### **Categories**

1. In this Event, there will be no distinction of classes or categories.

### **Article 16**

#### **Certification of the race**

1. The Race, not having a competitive nature, will not use any timing system. However, there will be prizes awarded to the first 3 (three) male and female classified.

### **Article 17**



## Ratification of classifications

1. The Race, not having a competitive nature, will not use any timing system.

### **Article 18**

#### Cash prizes

1. There will be no cash prizes awarded in the EDP 8K.

### **Article 19**

#### Other Prizes

1. All athletes taking part in the Race will receive an official medal and other souvenirs relating to the Race.

### **Article 20**

#### Equipment collection

1. There will be no equipment collection at EDP 8K.

### **Article 21**

#### Sports insurance

1. The MCP will provide a medical assistance service throughout the race and at the finish line, where a hospital tent will be set up.
2. Without prejudice of the previous number, the MCP will provide a sports insurance policy to all the participants of the Event, through a contract signed with an insurance company, in accordance with the legal regime of the compulsory sports insurance, as stated in Decree-Law nº 10/2009 of the 12th January, and for that purpose, will benefit from the minimum insurance coverages stated in the referred diploma.
3. In case of accident, claimants must contact the MCP through the email [geral@maratonaportugal.com](mailto:geral@maratonaportugal.com) and then fill in the accident form to be sent to the insurer by the MCP.

### **Article 22**



## Data protection measures

1. The MCP will process the personal data of the Athletes and the holders of the Athlete's parental responsibilities, when the Athlete is a minor, for the following purposes:

- a) regular development of the Race;
- b) preparation of tables of results/classifications;
- c) sending important information about the participation in the Event;
- d) validation of the sportive insurance
- e) marketing actions of the MCP;
- f) communications of future similar events; and
- g) marketing actions by partners/sponsors.

2. The information on how the MCP processes personal data and on your rights is set out in Appendix 1 to these Regulations and in the registration form, of which it is an integral and inseparable part.

## Article 23

### Term of responsibility

1. The athletes, when registering in the Event, sign a term of responsibility with the following content:

a) In the case of Athletes of legal age:

*"1. I have read and agree with the Rules of the EDP 8K, available on the official website of the race;*

*2. I am aware that I am in physical condition to participate in the Event;*

*3. I declare that I will refrain from participating in the race if my physical condition changes after registering in the race and that I will immediately leave the race as soon as I detect signs of weakness and/or indisposition;*

*4. In case of emergency I authorize medical assistance in the race and, if necessary, emergency transport to a hospital;*

*5. I am aware of the contents of the insurance policy and I have read the specifics of the same, contained in the Race Rules;*

*6. I participate in the race of free and spontaneous will, exempting the MCP, partners, directors, collaborators and other companies linked to the organization*





*of the event, from any responsibility resulting from my participation in the race, before, during or after the same (namely, in the case of loss of personal objects by theft or other circumstances)."*

b) In the case of underage Athletes:

*"1. I have read and agree with the Rules of the EDP 8K, available on the official website of the race;*

*2. Of my knowledge I am in physical condition to participate in the Race;*

*3. I declare that I will refrain from participating in the race if my physical condition changes after registering in the race and that I will immediately leave the race as soon as I detect signs of weakness and/or indisposition;*

*4. In case of emergency I authorize medical assistance in the Race and, if necessary, emergency transport to a hospital;*

*5. I am aware of the content of the insurance policy and I have read the specifics of the same, contained in the Race Rules;*

6. I participate in the Event of free and spontaneous will, exempting MCP, partners, directors, collaborators and other companies connected to the organization of the Event, from any responsibility resulting from my participation in the Event, before, during or after the Event (namely in case of loss of personal objects by theft or other circumstances)."

## **Article 24**

### **Doping Control**

1. There will be no doping control in the EDP 8K.

## **Article 25th**

### **Cancellation due to Force Majeure Reasons**

1. The cancellation of the race may occur due to force majeure, beyond the control of the MCP.

2. For the application of these Regulations, "force majeure" is understood as all unforeseeable or unavoidable events, whose effects occur regardless of the will or circumstances and which the MCP is not capable of justifiably preventing or resisting, including namely acts of hacking, computer viruses, earthquakes floods, storms, cyclones, electrical discharges (natural or network), fires, lightning or explosions and other natural disasters, acts of war and terrorism, social disturbances, fuel and power



shortages and pandemics having a serious impact on public health, and general mandatory confinement decreed by the competent public authorities.

3. If the postponement of the Event is determined, the MCP guarantees the automatic transfer of the entries of all athletes to the new proposed date.

4. If the Event is cancelled due to force majeure reasons, there will be no refund of the Event registration fee.

## **Article 26**

### **Alteration of the Race Course**

1. The MCP may, in exceptional cases, have to change the Race course, namely, the starting and/or finishing place, as well as the Race times.

2. Exceptional cases" are understood as any fact that prevents the accomplishment of the Event in the exact terms foreseen in these regulations, that are considered "force majeure", as defined in the previous article, but that do not generate the cancellation of the Event.

3. 3. If the course of the Event is changed in exceptional cases, there will be no refund of the entry fee.

## **Article 27**

### **Prohibited Objects**

1. To preserve the security of the Race, athletes will not be allowed to participate on bicycles, accompanied by animals, with baby carriages, skateboards, skates, scooters, or any other motorized devices, and athletes are not allowed to carry or bring with them prohibited objects or substances that may generate or enable acts of violence.

## **Article 28**

### **Doubts and Complaints**

1. Complaints must be made according to WA's principles. There will be a fee of 50,00 euros (fifty euros) for each complaint, which will be deposited with the MCP until the situation is solved. The amount will be refunded in case of acceptance. The time to analyze the complaint will be in line with the need to consult adjacent elements for the perfect knowledge of the situation.

2. MCP has several platforms to support the participants' doubts, which should be consulted if necessary.



3. Any cases not covered by these Regulations shall be resolved by the Technical Director of the Event, in accordance with the legislation and regulations in force.
