



## REGULATIONS

1. Integrated in the program of the EDP Half Marathon in Lisbon, the Mimosa Passeio da Família is a social event, open to all who want to participate and takes place on Saturday morning, march 11 at 11:00am
2. The concentration, start and finish areas of the event is in the same place: Museu da Electricidade, Av Brasília, next to Estação Fluvial de Belém.
  - 2.1. After the start, participants will follow Av. Brasília to Viaduto de Alcântara, turn right towards the Docas área. After passing the restaurant area, turn left until you find the river and then turn right along its bank, until they reach the Museu da Electricidade;
  - 2.2. This course is about 4 000 meters long.
3. All participants will receive t-shirts, medals and various gifts.
4. Registration for this event is free of charge and can be done online at [www.maratonaclubedeportugal.com](http://www.maratonaclubedeportugal.com) or at Seaside SporExpo, the official place to collect the Participation Kit
5. Duly registered participants may collect their bib number and participation kit at Centro Cultural de Belém on March 9 and 10 2023, no documentation being distributed on the day of the event.
  - 5.1. To pick up the bib number, it will be necessary to present the printed document of the online registration and the identification document of the participant.
6. The organization has structured a medical assistance service, under the guidance of a specialized team of professionals, although it is not responsible for any accident that may occur during this event.





7. Athletes duly registered will be covered by personal accident insurance, as provided for in n.º 1 of article 9º of DL n.º 146/93 of April 26, with an 28 000,00EUR for death or permanent injury and treatment costs of up to 4 514,00 EUR although the organization has a medical assistance service throughout the course and in the finish line area, where a Hospital tent will be installed. Participants must meet the necessary health conditions for the effort inherent in the race, assuming after registration that they feel physically and psychologically fit for the effort. In the event of an accident, they should contact Maratona Clube de Portugal (MCP) via email [geral@maratonaportugal.com](mailto:geral@maratonaportugal.com) so they can fill out the [Accident Form](#) to be sent to the insurance company by MCP.
8. The athlete's guardian, when registering, authorizes the transfer, free of charge and unconditionally, to the organization of the event and to its associates and sponsors, the rights to use his/her image as captured in the footage or photos that will take place during the event, authorizing their reproduction in communicational support pieces.
9. The organization reserves the right to use the database with the elements filled in by the guardians of the participants in their eventual promotional pieces or other actions.
10. When registering, the guardians of all participants automatically declare that they agree with the following disclaimer:
  - 10.1. I have read and agree with the Regulations of Maratona Clube de Portugal, available on the event's website;
  - 10.2. I am aware of the health conditions of my pupil and I am responsible for being physically and psychologically able to participate in the competition;





- 10.3. I assume that I will abstain my pupil from participating in the event if his/her condition change after registration;
- 10.4. I am aware of the content of the insurance policy and have read it's specifications;
- 10.5. By participating in the event, I authorize, free of charge and unconditionally, that the organization and its partners use the image of my pupil as well as my own. By this instrument, I grant all rights to use the images, captured in photographs and footage that will take place during the event, waiving the receipt of any amount that may be earned with its dissemination in support communication pieces;
- 10.6. I declare that my pupil participates in the event of his/her own free will, exempting the organization, partners, directors, employees and other companies linked to the organization of the event from any liability resulting from their participation in the event, before, during and after it (eg loss of personal belongings due to theft or other circumstances).
11. The event can be canceled due to major factors beyond the organization's control (extreme weather conditions, demonstrations, government restrictions, etc...). In case of postponement, the organization guarantees the automatic transfer of registrations of all participants to the new date. The organization may, in exceptional cases, have to change the course, namely the place of start and/or finish areas, as well as the race times.
12. The omissions of this regulations will be resolved by the technical Director of the event according to the official regulations.
