



REGULATIONS

1. Integrated in the program of the EDP Half Marathon in Lisbon, the Mimosa Passeio da Família is a social outing, open to all who want to participate and takes place on Saturday morning, March 11th, at 11:00 am.
2. The concentration, departure and arrival of the participants, is at the same place: Electricity Museum, Av. Brasília, next to the Belém Fluvial Station.
 - 2.1. After the departure, follow Av. Brasília to the Alcântara viaduct, turn right towards the Docas area. After passing the restaurant area, turn left until you find the river and then turn right along its bank, until you reach the Electricity Museum;
 - 2.2. This route is about 4,000m long.
3. All participants will receive t-shirts, medals and various gifts.
4. Registration for this event is free of charge and can be done online at <https://www.maratonadelisboa.com> or at SportExpo, the official place to collect the Participation Kits.
5. Duly registered participants may collect their bib number and respective “athlete kit” at the Centro Cultural de Belém on March 9th and 10th, 2023, with no documentation being distributed on the day of the competition.
 - 5.1. To collect the bib number, it will be necessary to present the printed document of the online registration and the identification document of the respective athlete.
6. The organization has structured a medical assistance service, under the guidance of a specialized team of professionals, although it is not responsible for any accident that may occur during this event.
7. Athletes will benefit from personal accident insurance, as provided for in paragraph 15 of article 18 of Decree-Law no. treatment costs up to 4000,00 EUR, although the organization has a medical assistance service throughout the race and in the finish area where a hospital tent will be installed.





REGULATIONS

8. The athlete's guardian, when registering, authorizes the transfer, free of charge and unconditionally, to the organization of the event and to its associates and sponsors, the rights to use his image as captured in the filming or photos that will take place during the event, authorizing their reproduction in communicational support pieces.
9. The organization reserves the right to use the database with the elements filled in by the guardians of the participants in their eventual promotional or other actions.
10. When registering, the guardians of all participants automatically declare that they agree with the following disclaimer:
 - 10.1. I have read and agree with the Regulations of Marathon Clube de Portugal, available on the event's website;
 - 10.2. I am aware of the state of health of my student and I am responsible for being physically and psychologically able to participate in the competition;
 - 10.3. I assume that I will abstain my student from participating in the event if my health conditions change after registration;
 - 10.4. I am aware of the content of the insurance policy and have read the specifications, contained in the Regulation of the Event;
 - 10.5. By participating in the event, I authorize, free of charge and unconditionally, that the organization and the partners of the test use the image of my student. By this instrument, I grant all rights to use the image of my student, captured in photographs and footage that will take place during the event, waiving the receipt of any amount that may be earned with its dissemination in support communication pieces;
 - 10.6. I declare that my student participates in the event of his/her own free will, exempting the organization, partners, directors, employees and other companies linked to the organization of the event from any liability resulting from their participation in the even, before, during and after it (eg loss of personal belongings due to theft or other circumstances).





REGULATIONS

11. The omissions of this regulation will be resolved by the technical director of the event and according to the official regulations and opinions of the FPA.

12. The event can be canceled due to major factors beyond the control of the organization (extreme weather conditions, demonstrations, government restrictions, etc.). In case of postponement, the organization guarantees the automatic transfer of registrations of all athletes to the new proposed date. The organization may, in exceptional cases, have to change the route, namely the place of departure and/or arrival, as well as the race times.
